# MOJ – UPDATE ON ACTIVITIES MAY – SEPTEMBER 2017

- Wide public debate on amendments to the Constitution in the part relating to the judiciary
- □ In May 2017 the MoJ launched a consultative process with civil society. Public invitation for the participation in a consultative process was published on 19 May 2017 CSOs invited to submit proposals for amending the Constitution in the part related to the judiciary
- Analysis of received comments/suggestions from the experts and CSOs and preparation of the proposal
- Two roundtables were organized (21 July and 7 September 2017) in Belgrade with CSOs where the proposals received were considered more closely. The organization of the third roundtable in Kragujevac is in progress.




