INTRODUCTION

The prosecutor's office web sites analysis includes 87 web sites:

Basic Prosecutor's Offices: 58 web sites
Higher Prosecutor's Offices: 25 web sites
Appeal Prosecutor's Office: 4 web sites

The analysis was conducted based on 30 relevant sources in the period between October 27th 2016 and February 10th 2017. The data was gathered through the web access to the prosecutor's office web sites, as well as through direct communication with the prosecutor's offices.


The analysis covers the aspect of uniformity of prosecutor's office web sites, as well as the technological-administrative aspect, through the following categories:

- Presence on the internet
- Finance and development
- Availability on the internet
- Administrative-technical presentment
- Specific contents and online services
- User interface
- Compatibility with mobile platforms
- Design and visual identity
- Content Storage "Web Hosting"
- Content management
- Human resources


RESULTS AND RECOMMENDATIONS

PRESENCE ON THE INTERNET

1. Prosecutor's Offices in the Republic of Serbia have been present on the internet since 2007. The chart below shows number of prosecutor offices websites that are developed in period 2007-2016.




2. A significant number of prosecutor's offices still does not have a web page. It is very important that all prosecutor's offices have their own web sites, so as to enable end users to access the prosecutor's offices services and information on the internet.




FINANCE AND DEVELOPMENT

3. The development of the majority of prosecutor's office web pages is self-financed and /or self-supported. As a result of the individual initiatives for the development of websites, content and visual identity of the websites significantly differs.



4. A significant number of prosecutor's offices participated in designing and developing their web sites.




AVAILABILITY ON THE INTERNET

5. All existing prosecutor's office web site system services and structures are up- and running. Continuous and easy access to prosecutor's office web sites is important, so end users can easily access prosecutor's office services over the internet.


ADMINISTRATIVE - TECHNICAL PRESENTMENT

6. Majority of prosecutor's office web pages are registered under the official domain (*.jt.rs). A few prosecutor's offices are registered different domains. It is recommended that all of the prosecutor's offices web sites are registered under the same domain (*.jt.rs). It is recommended that all prosecutor's offices remain unified under a specific technical entity, so as to assure the users to the validity of content and services of the web site.




SPECIFIC CONTENT


- 7. It is evident that the structure, content and services of prosecutor's offices web sites vary significantly. It is recommended that the structure of content and electronic services, be equalized through a centralized/decentralized system of prosecutor's office web sites.
- **8.** Specific content is assessed through presence of the following segments and structures on the prosecutor's office websites:
 - a. Availability of the forms and templates, so that the end users can access the Prosecutor's Office forms and templates directly through the internet. The presence of Forms and Templates on the internet leads directly to the Prosecutor's Office end service improvement and reduces the workload for single PO's staff. In the chart below it's evident that the majority of the websites have that option on their web locations, but significant number of PO's web sites still don't.




b. Availability of the general information of the single Prosecutor's office, so the end users can find out more details about Prosecutor's Office. In the chart below it's evident that majority of the websites have that option on their web location.




c. Availability of the electronic contact section, so the end users can contact the Prosecutor's Office directly through internet. In the chart below it's evident that majority of the websites have that option on their location. Also a certain number of Prosecutor's Office websites developed a contact service operating through a web form that does not require a configured e-mail client on the end user's device side.



d. Availability of the news section, so the end users can be informed about the Prosecutor's Office activities. In the chart below it's evident that majority of the websites have that option on their location.



9. In most cases the web sites are updated periodically. It is recommended that the prosecutor's offices are encouraged to post as much information as possible on a daily basis (news, success stories ad all other relevant information that will improve communication between public prosecutor offices and public).



USER INTERFACE

10. Unevenness of structure and various user interface components is evident through different usability, structure of components and performances of the user interface, as well as the W3C standard compatibility¹, which assures access on all devices and platforms. Equalization and centralized development of the user interface is recommended through the centralized/decentralized system of prosecutor's office web sites.


11. Website infrastructures performance is important. Through the direct measurement of "Google Page Speed Insight" web services, Prosecutor's Office websites showed average score in the chart below.




COMPATIBILITY WITH MOBILE PLATFORMS


12. A significant number of web sites does not have mobile platform version. Due to the increasing number of smart mobile devices, it is necessary to update the user interface for mobile platforms as well. Central development of user interface (figure 9) would be the main solution.



DESIGN AND VISUAL IDENTITY OF PROSECUTOR'S OFFICES WEB SITES

13. An unevenness of visual identity of prosecutor's office web pages is evident. Web design of most web locations is appropriate for the prosecutor's office web site, the design structures are balanced out, and text structures are correct.






14. The average lifespan of a last version of the web site is **2** years. As for the user interface (figure 9) equalization and central development through a centralized / decentralized system of prosecutor's office web sites is recommended.


STORAGE OF CONTENTS OF PROSECUTOR'S OFFICE WEB SITES - "WEB HOSTING"

15. The content of the majority of prosecutor's office web sites is located on a public web hosting. Due to the possibility of unauthorized access as well as the confidentiality of the users' information gathered through the electronic services, internal storage of contents is recommended.




CONTENT MANAGEMENT


16. Site content management is inconsistent. The majority of prosecutor's office web site content is organized through the CMS – Content Management System⁴ so non-IT professionals have direct and executive access to website content. A significant amount of web sites does not have a content management system, and changes are made through directly editing the HTML code, instead.


17. The web sites whose content is organized through the site management system, use at least 3 different CMS platforms. It is recommended that all web sites use a single platform for site management through a centralized / decentralized system of prosecutor's office web sites



HUMAN RESOURCES

- **18.** The majority of prosecutor's offices have a trained person within the prosecutor's office, responsible for the maintenance and updating the web site. Prosecutor's offices in Serbia have good support through qualified IT personnel.
- **19.** The prosecutor's office web development teams are not connected. Networking and cooperation of web development teams is recommended as it is necessary for a high quality technological-technical exchange. The most promising members of the team could

be the backbone of development/maintenance of centralized/decentralized system of prosecutor's office web sites, through proper training.
